Motion unanimously approved.

Tim Vandevelt presented the Fire Department report to the Board. Discussed that the air Compressor as the circuit kept tripping the breaker and is now fixed. Discussed buying a new Thermal imaging camera. Cost is \$2500. Purchased a new gas detector. Cost was \$1500.00. The chief and officers discussed going to a tablet system. They are trying it out to see how it benefits the crew. There is one in the 1st fire truck and one in Tim's car. If it is beneficial there will be one for each chief and one for the tank truck. No personal data will be on them and security is primary focus.

Brian Crye reported that there were no issues at the WWTP. Everything is running well.

Charlie Floesser, CEO discussed issues with a drain that needs to be fixed in the Save A Lot parking lot. Was told it was going to be fixed last week but hasn't. Waiting on contractor and the section has been coned off.

Owners of George's restaurant were notified regarding the garbage that is still present and how it needs to be disposed of as it is considered a health hazard. Village crew can clean it up and charge owners. Charlie will follow up with owners.

D.A. Greg McCaffrey presented to the Board regarding the Legalization of Marijuana.

Discussed private citizen concerns as well as public figure concerns. Discussed how the legalization of marijuana is a game changer and is very different from alcohol.

Ambulance report: Updates will be coming

Ben Luft discussed the sewer issue on Hill View Terrace as well as the kiosk that may be going in Mark Tubbs park. Ben will be looking in to see if it is still a possibility.

Board presented with a proposition to refund Sharon Paulino regarding a high water bill due to a leak. Board agreed to allow a refund of \$20.00.

Mayor Carl Luft relayed information from Bruce Capron for the HFLCD regarding the Tax Exemption Municipal Agreement. The proposal is to pay \$1.00 for the first 15 years and renewal of this proposal will be renewed after the 15 years is up. This proposal is in motion.

USDA Form for the Volunteer Ambulance Building must be completed by April 25, 2019.

Jerry Warsaw will be looking in to the health insurance issue of pre-tax or not. A 125 Cafeteria Plan will need to be written in order to pay \$500.00 for the 1st year and \$250.00 a year Beginning the 3rd year. He will report his findings to the Board.
